An off-highway vehicle (OHV) is a self-propelled vehicle used for recreation or cross-country travel on public lands, trails, easements, lakes, rivers or streams.

Examples include but are not limited to: motorcycles, quadricycles (also known as 4-wheelers), dune buggies, amphibious vehicles, air cushion vehicles, and any other means of land transportation deriving motive power from any source other than muscle or wind.

NOT included in the legal definition of off-highway vehicles are: snowmobiles; vehicles designed primarily for travel on, over or in the water; and vehicles except motorcycles and quadricycles which are otherwise licensed under Montana laws (such as sport utility vehicles and 4x4 trucks).

Mailing Lists – Montana Fish, Wildlife & Parks receives requests for mailing lists. **Please note, even if you chose 'No,' under State law the Department is required to allow individuals who wish to compile their own mailing list access to Department records including your name, address, gender, residency status, license type, district applied for and whether you were successful.

Please Remember:

1. All permits are nontransferable and nonrefundable.
2. The permit is valid for the specified calendar year.
3. The permit sticker must be displayed in a conspicuous manner on the OHV.
4. The permit is not proof of ownership.
